THEFT: A victim reported that his daughter's iPhone 5s was stolen while she was at the Funplex, 3320 Route 38 between 3:30 pm and 6:00 pm on February 14th.

ARREST: On January 27th Avis car rental located at 1111 N. Route 73 reported that a 2015 Toyota 4Runner had been stolen from their lot. The investigation revealed that an employee of Avis, Brian G. Fisher, age 28, of Haddonfield, NJ stole the vehicle. On February 16th at 11:55 pm officers arrested Mr. Fisher and charged him with burglary and theft of a motor vehicle. Bail was set at \$30,000.00 with no 10% option and he was committed to the Burlington County Jail.

ARREST: On February 17th at 3:27 am Mount Laurel Police conducted a motor vehicle stop on Route 73 near Fellowship Road. During the stop officers arrested Michael F. Delaney, age 36 of Brigantine, NJ. He was charged with driving while intoxicated and possession of prescription legend drugs. He was released pending a court hearing.

CRIMINAL MISCHIEF: A victim reported that three tires were punctured on her vehicle between February 14th and February 16th while it was parked on the 1300 block of Wharton Road.

ATTEMPTED THEFT: On February 17th at 2:30 pm Mount Laurel Police responded to an attempted theft at Target on Centerton Road. Two suspects attempted to walk out of the store with two Dyson Vacuum cleaners. Loss prevention employees confronted the suspects who then ran out of the store leaving the merchandise behind.
