ARREST: At 7:15 am on January 27th Mount Laurel Police conducted a motor vehicle stop on Church Road near Waverly Avenue. During the stop officers arrested Henry A. Greene Jr., age 21, of Camden, NJ. He was charged with possession of less than 50 grams of marijuana and released pending a court hearing.

ARREST: At 11:41 am on January 27th Mount laurel Police responded to a hotel on Nixon Drive for a disturbance in the lobby. The investigation revealed that Brent D. Greene, age 30, of Moorestown, NJ entered a vacant hotel room and was staying there until he was discovered by the staff. During the investigation Green provided a false name to officers. He was arrested and charged with trespassing, theft of services, and hindering his own apprehension. Greene was released pending a court hearing.

CRIMINAL MISCHIEF: A resident of East Peachtree Court reported that all four tires of her vehicle were slashed during the early morning hours of January 27th.

SHOPLIFTING: On January 27th Mount Laurel Police responded to Wegman's, 2 Centerton Road for a past tense shoplifting report. A male and female suspect hid \$169.00 worth of baby formula in the female's purse and exited the store without paying.

The investigation determined that an unknown male customer started an argument with another male customer. The argument escalated into pushing and shoving. The suspect left the location prior to police arrival. No injuries were reported.

FRAUD: A victim reported that he received a \$2,000.00 check in the mail with a letter explaining that he had won the lottery. The \$2,000.00 was sent to him to pay the taxes on the winnings. The victim called the company on the letter and was told to deposit the check, keep \$500.00 and send the remaining \$1,500.00 back to them in them by Walmart Money Order. The victim deposited the check and wired the money. He then learned the check was fictitious.

ARREST: At 3:30 pm on January 29th Mount Laurel Police responded to Target on Centerton Road for a shoplifting in progress. The three suspects were stopped by police as they attempted to drive away. The investigation determined that two of the suspects stole \$198.00 worth of baby formula. Arlene West, age 58 of Trenton, NJ and Carrie F. Brown, age 50, of Trenton, NJ were both charged with shoplifting and committed to the Burlington County Jail. A third suspect, Victoria Williams, age 49, of Trenton, NJ was arrested for an outstanding warrant and turned over to another law enforcement agency.

THEFT: A resident of the 200 block of Everly Court reported that prescription medication was stolen from her purse during the overnight hours of January 28th into the 29th. The victim suspects an acquaintance she allowed to spend the night of the theft.

CRIMINAL MISCHIEF: During the overnight hours of January 28th into the 29th someone spray painted the letters "R. O" on the exterior wall of the restrooms at Laurel Acres Park on S. Church Street.

Ayala, age 45, of Mount Laurel reported that she was about to exit her vehicle at the hardware store when a man approached her from behind and stuck an object in her back. She was told not to turn around and the suspect took her purse containing prescription medication and ran off. Several officers to include a K9 officer responded to look for the suspect. Further questioning of the victim determined that no robbery had occurred and that she made a false report in order to obtain more medication. Ayala was arrested and charged with filing a false police report. She was released pending a court hearing.

ARREST: At 9:30 pm on January 31st Mount Laurel Police conducted a motor vehicle stop on Route 38 near Union Mill Road. During the stop officers arrested Tony Pressley, Jr., age 28, of Mount Holly. He was charged with possession of less than 50 grams of marijuana. He was committed to the Burlington County Jail.
