ARREST: On January 11th at 8:24 am Mount Laurel Police responded to a residence on the first block of Pheasant Drive for the report of a subject who was seen entering parked vehicles in the driveway. The suspect ran into a wooded area prior to police arrival. With the assistance of K-9 Gunner the suspect, Joseph D. Caprarola, age 19, of Moorestown, NJ was located and arrested. The investigation revealed that Caprarola entered several vehicles and a shed on the property. He stole a coat from one of the vehicles before being scared off by the resident. He was charged with burglary and theft with bail set at \$8,000.00. He was committed to the Burlington County Jail.

THEFT: A resident on the 100 block of Hartford Road reported that miscellaneous items valued at \$160.00 were stolen from an unlocked vehicle between January 9th and 10th.

THEFT: A victim reported that his iPhone 6 was stolen from his gym bag that was left unattended while he played basketball at the YMCA on Centerton Road on January 11th at 4:00 pm.

ARREST: On January 11th at 7:40 pm Mount Laurel Police conducted a motor vehicle stop on Route 38 near Briggs Road. During the stop officers arrested Gloria V. Brandon, age 31, of Pennsauken for several criminal and traffic warrants. She was also found in possession of marijuana. She was charged with possession of less than 50 grams of marijuana and turned over to another law enforcement agency for the warrants.

Thornton was charged with possession of heroin, possession of a hypodermic syringe, and loitering for the purpose of engaging prostitution. She was turned over to another law enforcement agency for an outstanding criminal warrant. Kee was charged with possession of a hypodermic syringe and loitering for the purpose of engaging in prostitution. She was released pending a court hearing.
