ARREST: At 9:07 am on May 25th Mount Laurel Police responded to the Wegman's on Centerton Road for a shoplifting report. Arriving officers located two suspects exiting the store with merchandise concealed under their clothing. Officers arrested Michael W. Arnold, age 22, of Willingboro, NJ and Victor A. Devirgilio, age 23, of Staten Island, NY. They were charged with shoplifting and released pending a court hearing.

ARREST: At 5:34 pm on May 25th Mount Laurel Police responded to a minor motor vehicle crash on Route 73 near Commerce Parkway. During the investigation officers arrested James W. Lavelle, age 26, of West Berlin, NJ. He was charged with driving while intoxicated, possession of cocaine, possession of a hypodermic syringe, and possession of drug paraphernalia. He was released pending a court hearing.
