**ARREST:** On February 29<sup>th</sup> at 10:22 pm Mount Laurel Police conducted a motor vehicle stop on Route 38 near Lenola Road. During the stop officers arrested Terrence J. Foster, age 22, of Burlington, NJ after he provided a false name to officers in an attempt to avoid arrest for an outstanding warrant. He was charged with hindering his own apprehension and released after satisfying the warrant.

**TRESSPASS (Summit Apartments)** On March 1<sup>st</sup> at 1:50 am Mount Laurel Police responded to Bradley Court for the report of a man opening car doors. On arrival officers observed a suspect trying to open a car door. The suspect fled when he saw the police vehicle. The investigation revealed that the suspect entered several unlocked vehicles but nothing was taken.
