CRIMINAL MISCHIEF: A resident on Knighton Lane reported that a pumpkin was thrown against their vehicle causing damage. The incident occurred during the early morning hours of October 31st.

ARREST: At11:13 pm on November 4th Mount Laurel Police conducted a motor vehicle stop on Union Mill Road near Morning Glory Drive. During the stop the officer smelled the odor of burnt marijuana inside of the vehicle and saw a marijuana cigarette on the center console. After speaking with the three occupants the officer suspected that the vehicle contained additional criminal evidence. As a result of the investigation all three occupants were arrested. A loaded handgun with its serial number filed off was recovered along with a switchblade knife, prescription legend drugs, additional marijuana, drug paraphernalia, and a quantity of money. A 17 year old female from Cinnaminson was charged with possession of a spring loaded knife and released to a family member. Casey G. Greatrex, age 19, of Mount Laurel was charged with possession of less than 50 grams of marijuana and released pending a court hearing, Uriel L. Savage, age 20, of Willingboro, NJ was charged with possession of a defaced firearm, unlawful possession of a weapon, possession with the intent to distribute a controlled dangerous substance, possession of prescription legend drugs, possession of less than 50 grams of marijuana, and possession of drug paraphernalia. Bail was set at \$58,500.00 with a 10% option and he was committed to the Burlington County Jail.

BURGLARY: During the overnight hours of November 4th into the 5th someone burglarized two businesses in the Masonville Square Shopping Center on the 200 block of Masonville Road. Someone gained entry to Angelo's II Pizzeria and Gel Nail Salon by prying open the back doors of both businesses. Money was stolen.

ARREST: At 8:50 pm on November 5th Mount Laurel Police stopped a suspicious person walking on Arbor Way at Church Road. During the stop officers arrested Dana M. Brown age 27, of Evesham, NJ for an outstanding warrant. She was also found in possession of drug paraphernalia. She was charged with possession of drug paraphernalia and released after satisfying her warrant.

OVERDOSE REVERSAL: At 4:13 pm on November 6th Mount Laurel Police responded to the parking lot of a diner on the 1100 block of Route 73 for the report of an unconscious female in a vehicle. Officers located a 23 year old female suffering from a suspected opioid overdose. Virtua Paramedics administered Narcan and reversed the overdose. She was transported to a local hospital for additional treatment.

THEFT: An employee from a business at 100 Century Parkway reported her iPhone 6 was stolen from her desk between 10:15 am and 10:40 am on November 4th.

THEFT: A resident on the 600 block of South Church Street reported that a Craftsman riding lawn mower was stolen from their front yard during the early morning hours of November 7th. The mower was for sale and was not secured by any locking device.

THEFT: A member of Giant Fitness, 1315 Route 73, reported that someone forced open a locker in the men's locker room and stole his wallet. The theft occurred between 2:15 pm and 2:40 pm on November 8th.

BURGLARY: During the overnight hours of November 7th into the 8th the Friendly's restaurant at 3047 Route 38 was burglarized. An unknown amount of cash was stolen from an office. Entry into the business was gained by forcing open a rear door and an interior office door.

THEFT: A member of Giant Fitness, 1315 Route 73, reported that his wallet was stolen after he accidentally dropped it on the floor while he was exercising. The theft occurred around 2:20 pm on November 9th.

ARREST: At approximately 7:00 am on November 10th Mount Laurel Police executed a search warrant at the residence of Kyle P. Raspatello, age 21, of Sternlight Drive, Mount Laurel. Raspatello was identified as a suspect in the recent string of commercial burglaries at the Friendly's Restaurant, Carlucci's Restaurant, Angelos II Restaurant, and Gel Nail Salon. He was subsequently charged with six counts of burglary, six counts of theft, six counts of criminal mischief, possession of crack cocaine and heroin, and possession of drug paraphernalia. Bail was set at \$65,000.00 with no 10% option and he was committed to the Burlington County Jail.
