VEHICLE BURGLARIES: During the overnight hours of October 27th into the 28th two unlocked vehicles were entered in the LeClub development off of Hartford Road. Money was stolen.

THEFT: A victim reported that she was at Starbucks on Fellowship Road at 2:00 pm on October 28th. Her purse was slung over the back of her chair and she noticed two males bend down near in a suspicious fashion and then leave the store. The victim checked her purse and discovered her wallet was missing. She confronted the two men in the parking lot and they returned her wallet.

BURGLARY: A residence on the 100 block of Phillips Road was burglarized between 12:00pm and 8:00 pm on October 28th. Jewelry was stolen. Entry was gained by breaking the glass of a rear sliding door.

ARREST: At 10:14 pm on October 28th Mount Laurel Police conducted a motor vehicle stop on Route 38 near Midlantic Drive. During the stop officers arrested Austin J. Brennan, age 18, of Burlington, NJ. He was charged with possession of less than 50 grams of marijuana and possession of alcoholic beverages. He was released pending a court hearing.

ARREST: Between March and October of this year Mount Laurel Police received 9 reports of dog feces being smeared on the vehicles belonging to a family on West Bluebell Lane. Their vehicles have also been damaged in the same time frame. Officers suspected a neighbor on West Bluebell Lane of committing the offenses due to a previous dispute between the two families. On October 29th at 1:13am an officer witnessed Kimberly D. Teitelman, age 45, of Mount Laurel smear dog feces on the victim's car. Teitelman was arrested and charged with stalking and harassment. Bail was set at \$3,000.00 with 10% option. She was released pending a court hearing after posting bail.

BURGLARY: Between 1:00 am and 7:00 am on October 29th the Friendly's restaurant at 3047 Route 38 was burglarized. An unknown amount of cash was stolen from an office. Entry into the business was gained through an unlocked door.

ARREST: At 3:57 pm on October 29th Mount Laurel Police responded to Wegmans on Centerton Road for a shoplifting report. During the investigation officer arrested Holly Hageman, age 32, of Atco, NJ and Ricky Rodriguez, age 37, of Landisville, NJ for attempting to steal \$134.00 worth of Red Bull energy drinks. Both were charged with shoplifting. Rodriguez was also charged with possession of hypodermic syringes. Both were released pending a court hearing.

SHOPLIFTING: At 1:22 pm on October 29th a suspect stole \$729.00 worth of merchandise from the Bed Bath & Beyond store at 8 Centerton Road. The suspect left the merchandise in the parking lot when he realized store employees were following him. He fled the area prior to police arrival.

ARREST: At 12:37 am on October 30th Mount Laurel Police conducted a motor vehicle stop on Masonville Road near Creek Road. During the stop officers arrested Jory M. Spencer-Williams, age 24, of Delran, NJ. He was charged with possession of less than 50 grams of marijuana and released pending a court hearing.

ARREST: At 6:39 am on October 30th Mount Laurel Police responded to the report of a suicidal man who was sitting in the intersection of Fellowship Road and West Park Drive. On arrival officers located 37 year old Michael A. Boswell of Durham, NC in the roadway. Officers shut down the roadway to traffic and attempted to speak with him. However, he was intoxicated and belligerent. He repeatedly told the officers they would need to shoot him. After exhausting all attempts to negotiate with Boswell officers took him into custody. He struggled and swung his fists at the officers as they took him into custody. An intoxicated relative of Boswell, who was standing nearby, ran up to the officers in an attempt stop them from making the arrest. When ordered to stay back he assumed a fighting stance threatening to punch an officer. He was arrested and resisted being taken into custody. The second man was identified as Spencer T. Allen, age 31, of Durham, NC. Boswell was charged with aggravated assault on police, resisting arrest, and obstructing a highway. He was transported to a local hospital for an evaluation. Allen was charged with obstructing the administration of law and resisting arrest. He was released pending a court hearing. One officer was injured during the altercation. He was treated for a leg injury and released from a local hospital.

CRIMINAL MISCHIEF: A resident of the 100 block of Ramblewood Parkway reported that during the overnight hours of October 30th into the 31st someone threw a pumpkin at their parked car damaging the headlight.

THEFT: Between October 29th and October 31st someone stole used cooking oil from a container behind the Al Fresco restaurant, 1155 Route 73. The oil was valued at \$60.00.

THEFT: A resident of the first block of Longbridge Drive reported that someone stole their mailbox during the overnight hours of October 31st into November 1st.

ARREST: At 6:45 pm on November 1st mount laurel police conducted a motor vehicle stop on South Church Street near Pleasant Valley Avenue. During the stop officers arrested Aaron M. Streater, age 40, of Camden, NJ. He was wanted for theft out of Los Angeles County, California for theft. He was charged with being a fugitive from justice with bail set at \$20,000.00 with no 10% option. He was committed to the Burlington County Jail.
