**ARREST:** At 3:09 pm Mount Laurel Police responded to Innova, 3718 Church Road for a trespassing complaint. Officers located Nicholas Delargey, age 20, of Glendora, NJ and arrested him for an outstanding warrant. He was then found in possession of two hypodermic syringes used to inject heroin. He was charged with possession of drug paraphernalia and released pending a court hearing after satisfying the warrant.

**ARREST:** At 11:09 pm on September 23<sup>rd</sup> Mount Laurel Police conducted a motor vehicle stop on South Church Street near Academy Drive. During the stop officers arrested Michael D. Orr Jr., age 41, of Mount Laurel. He was charged with driving while intoxicated and released pending a court hearing.

**CRIMINAL MISCHIEF:** On September 24<sup>th</sup> Mount Laurel Police responded to 75 Marter Avenue for a criminal mischief report. A door to a warehouse was forced open causing damage to the door sometime during the overnight hours. Entry was gained into the warehouse however it is under construction and nothing is kept there. A previously unreported incident occurred on September 17<sup>th</sup>.

**VEHICLE BURGLARIES:** During the overnight hours of September 24<sup>th</sup> in the 25<sup>th</sup> nine unlocked vehicles were burglarized in the Rancocas Pointe development near Creek Road and Centerton Road. Money and jewelry were stolen from the vehicles. A video surveillance video captured a suspect attempting to enter a vehicle at 4:25 am on September 25<sup>th</sup>.

**VEHICLE BURGLARY:** At approximately 1:00 am on September 26<sup>th</sup> an unlocked vehicle parked on the 800 block of Courtney Way was entered. Cash, an Apple Macbook Air, a Louis Vuitton Neverfull Bag, and a Gucci wallet were stolen.

**BURGLARY:** A resident on the first block of Arianas Court reported that their residence was burglarized. The investigation revealed that between 11:30 am and 1:15pm on September 27<sup>th</sup> someone forced open the front door of the residence. The suspect(s) searched through dresser drawers in the master bedroom however, nothing was taken.

**ARREST:** On May 8, 2016 Mount Laurel Police investigated a theft that took place at the 7-11 on Marne Highway. The investigation revealed that an employee stole \$1013.48. A warrant was issued for Christopher L. Collier, age 18, of Pennsauken, NJ charging him with theft on May 8<sup>th</sup>. On September 27<sup>th</sup> Collier was arrested by another law enforcement agency and turned over to Mount Laurel Police. Bail was set at \$2,500.00 with a 10% option. Collier was committed to the Burlington County Jail.
